

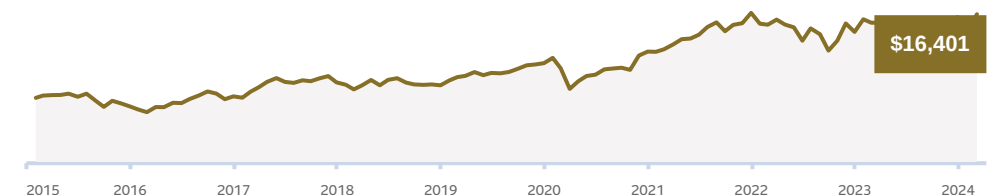

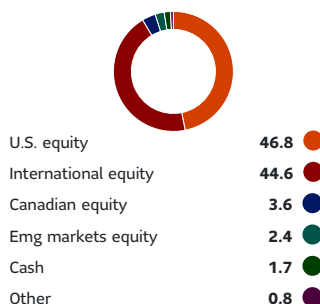

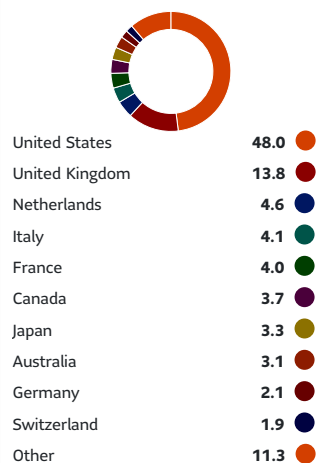
Asset allocation

% as of Dec 31, 2023



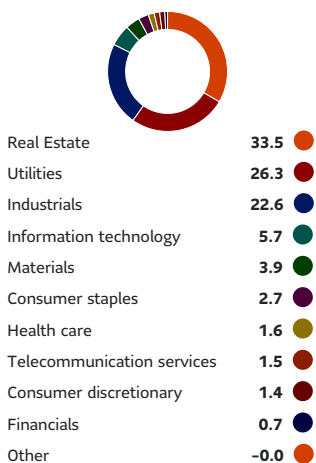
Geographic allocation
