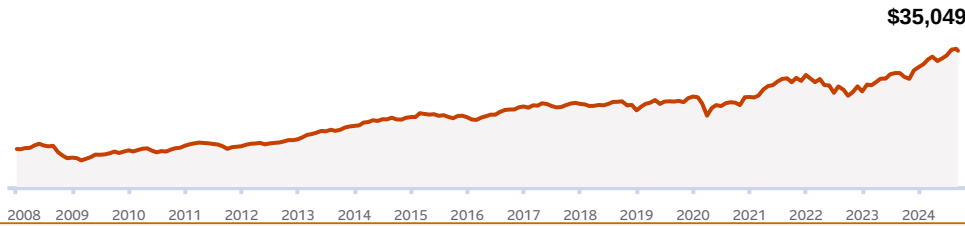


Sun GIF Solutions CI Canadian Equity Investment Series A
