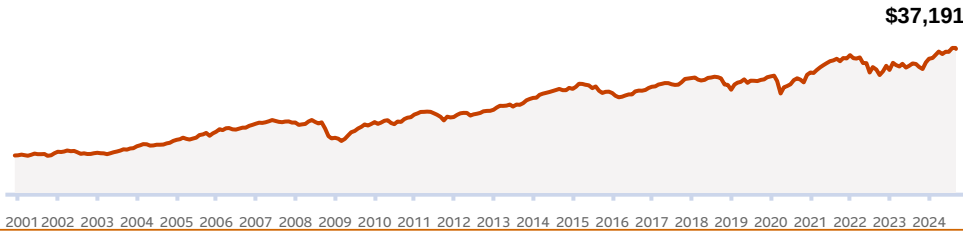


Sun Lifetime Advantage GIF CI Canadian Income & Growth A
