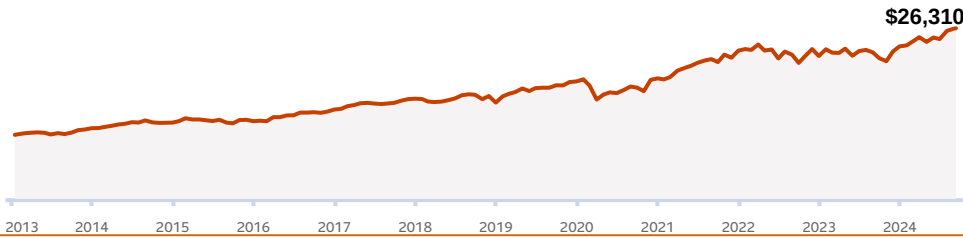

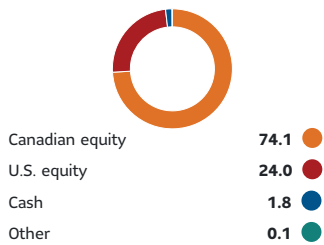

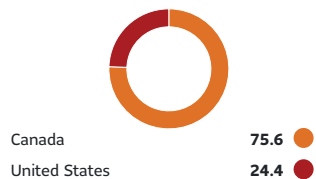
### Asset allocation

% as of Jul 31, 2024



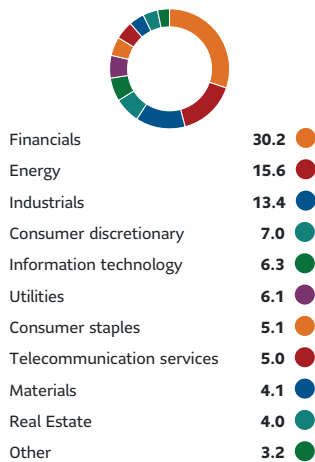
### Geographic allocation
