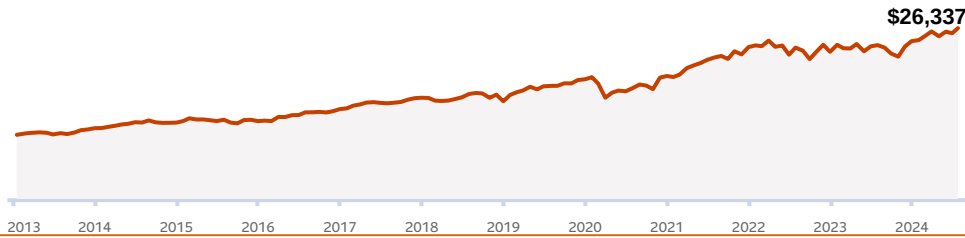

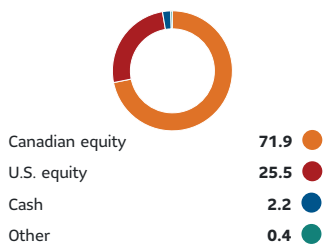

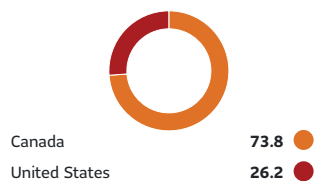
Asset allocation

% as of May 31, 2024



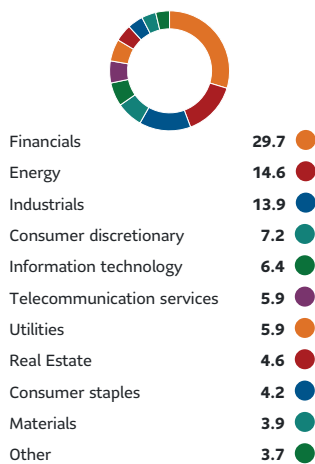
Geographic allocation
