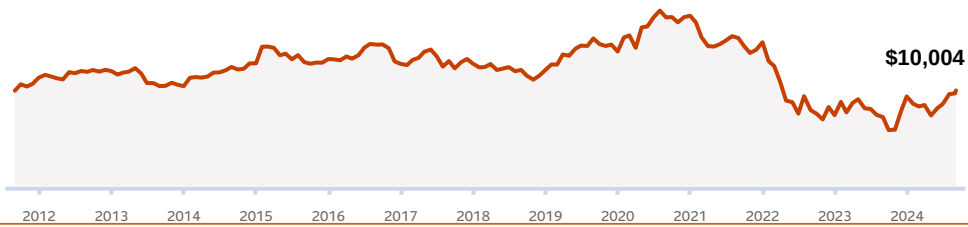


# Sun Lifetime Advantage GIF Sun Life Multi-Strategy Bond A

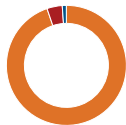

## Asset allocation

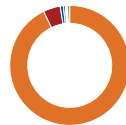
