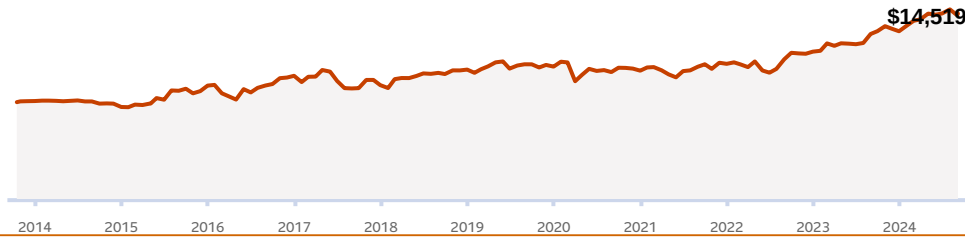


Sun GIF Solutions Fidelity Floating Rate High Inc Estate Series F
