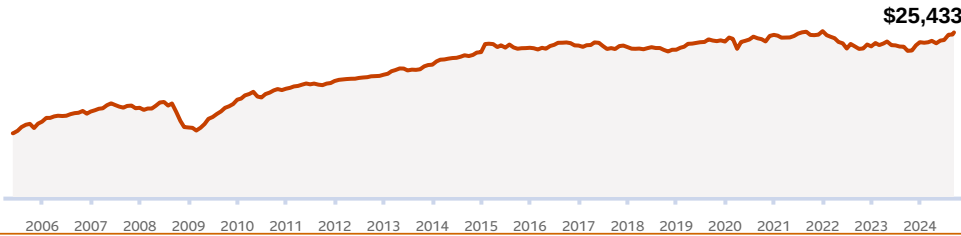


Sun Lifetime Advantage GIF Fidelity Income Allocation A
