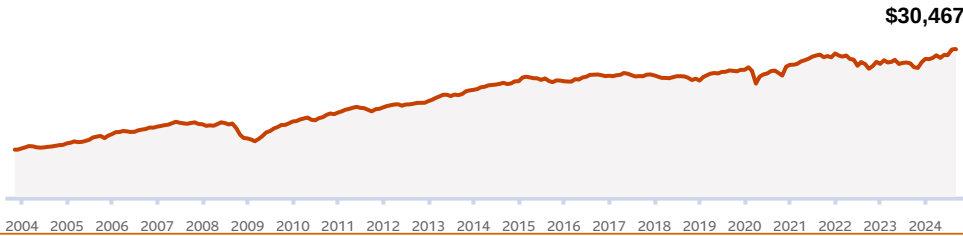


## Sun Lifetime Advantage GIF Fidelity Monthly Income A
