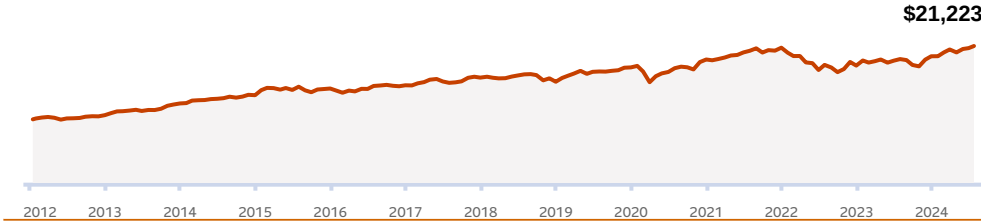


## Sun Lifetime Advantage GIF Sun Life Granite Balanced Growth F
