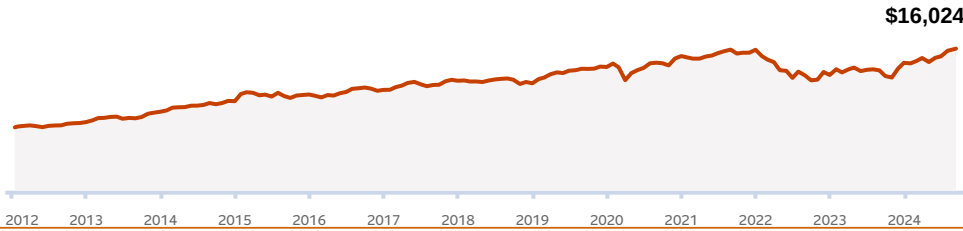


## Sun GIF Solutions Sun Life Granite Conservative Investment Series F
