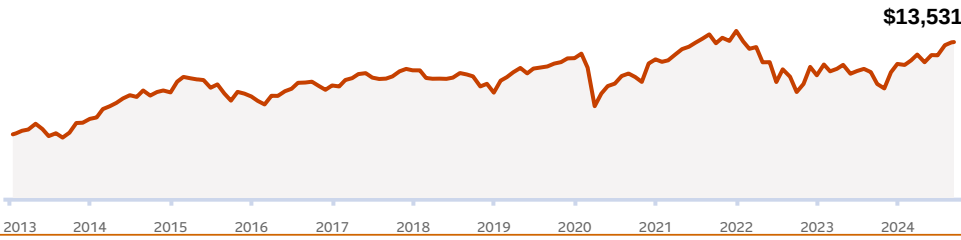


## Sun Protect GIF Sun Life Granite Enhanced Income A
