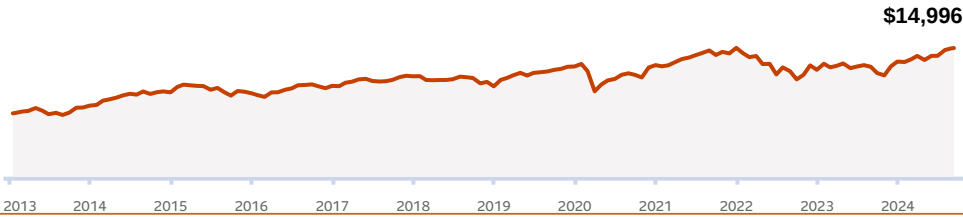


Sun Protect GIF Sun Life Granite Enhanced Income F
