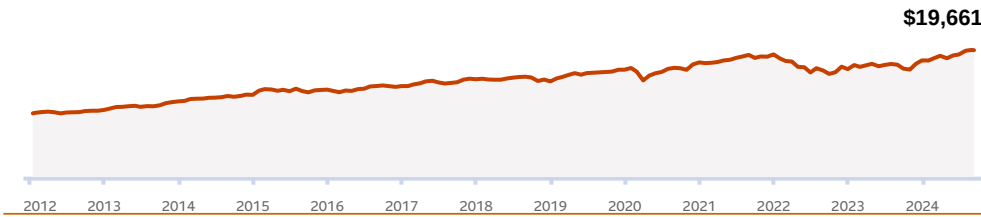


## Sun GIF Solutions Sun Life Granite Moderate Investment Series F
