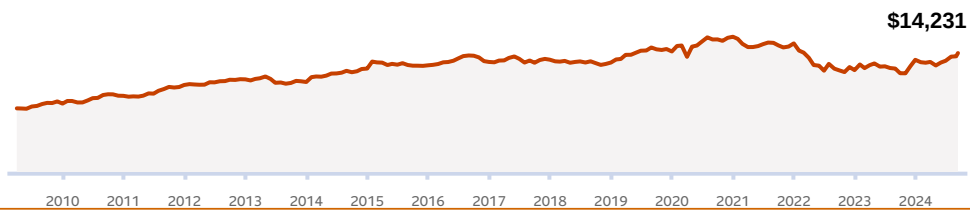


Sun GIF Solutions Sun Life MFS Canadian Bond Investment Series A

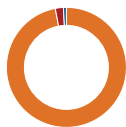
