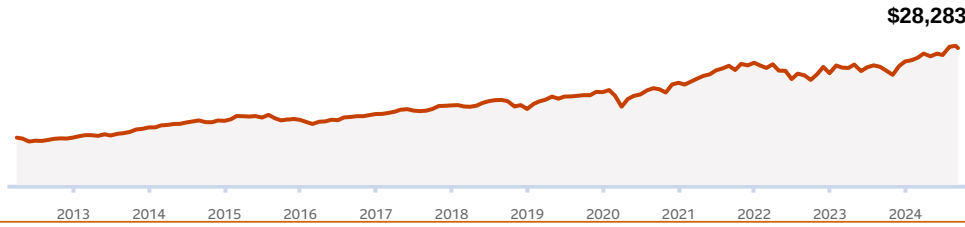


## Sun GIF Solutions Sun Life MFS Cdn Equity Estate Series O

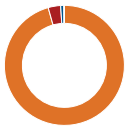
