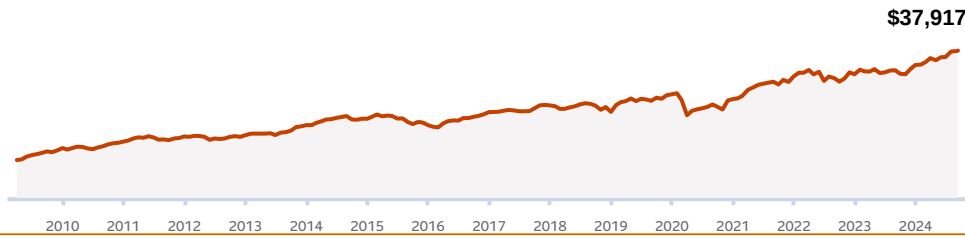


## Sun GIF Solutions Sun Life MFS Diversified Income Estate Series O
