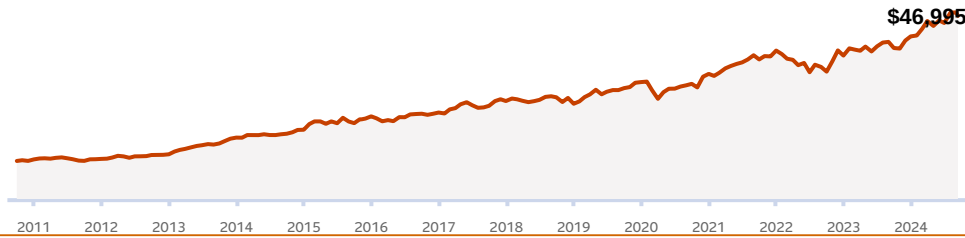


## Sun GIF Solutions Sun Life MFS Global Value Investment Series O
