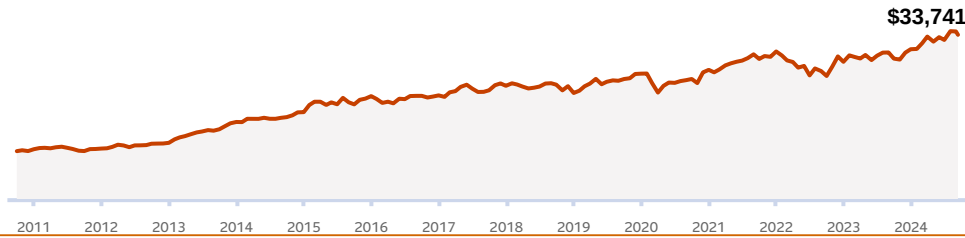


Sun Protect GIF Sun Life MFS Global Value A
