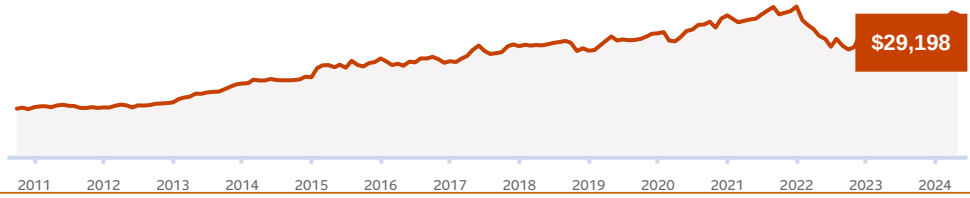


## Sun GIF Solutions Sun Life MFS International Value Estate Series A
