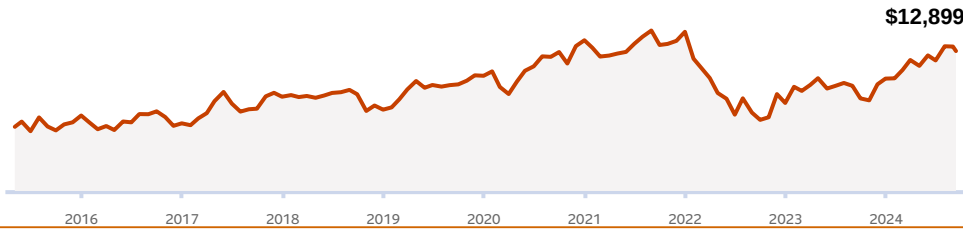


## Sun Lifetime Advantage GIF Sun Life MFS International Value Bundle A
