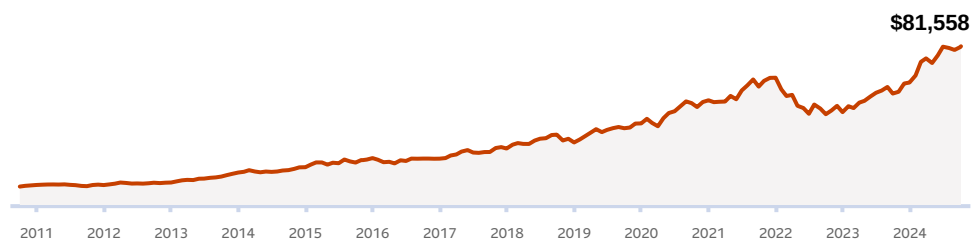


Key reasons to invest

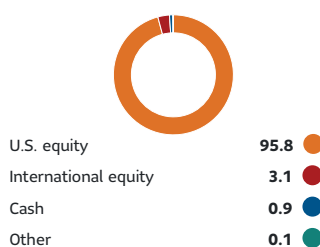

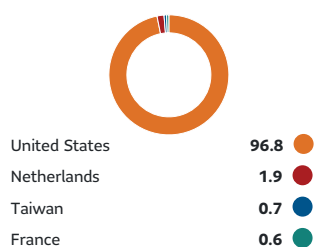
Asset allocation

% as of Jul 31, 2024



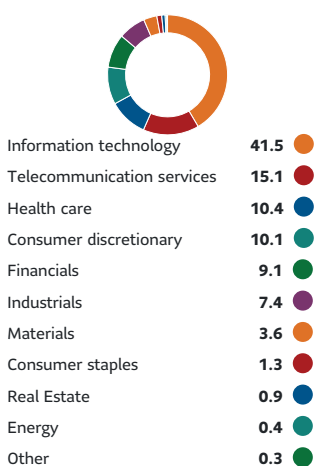
Geographic allocation
