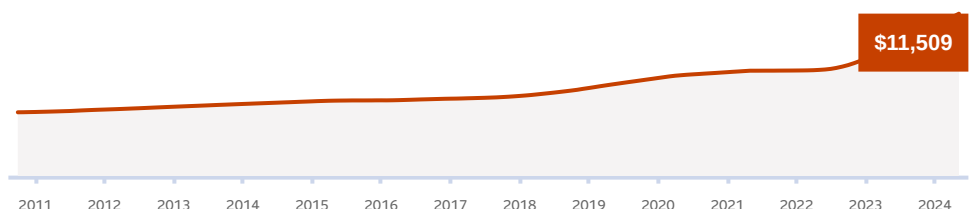


Sun GIF Solutions Sun Life Money Market Estate Series 0

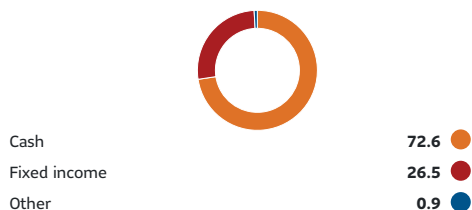
