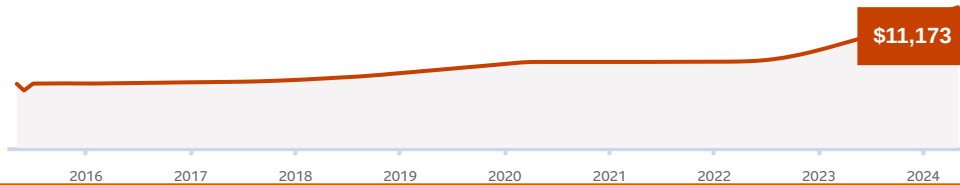


Sun GIF Solutions Daily Interest Investment Series A

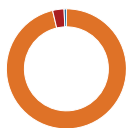
