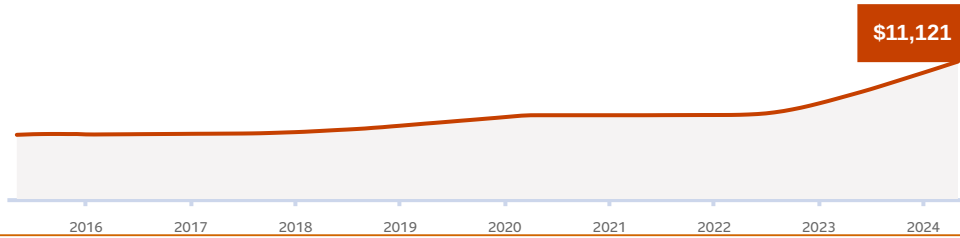


Sun Lifetime Advantage GIF Daily Interest A

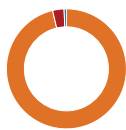
