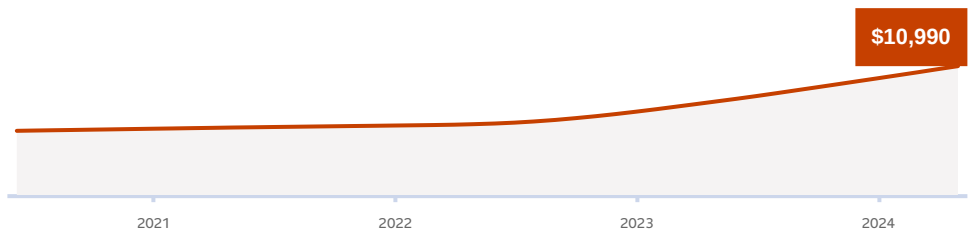


## Sun Lifetime Advantage GIF Daily Interest 0

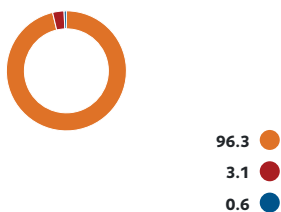
