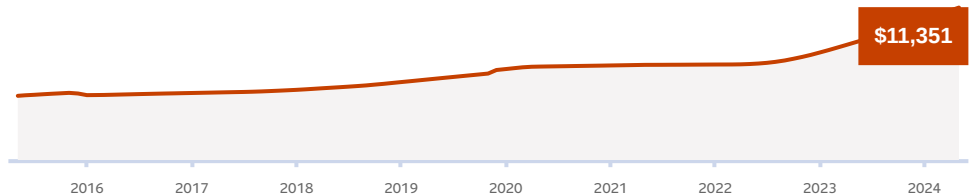


Sun GIF Solutions DCA Daily Interest Estate Series F

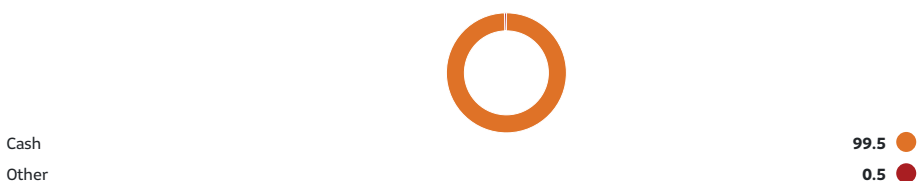
