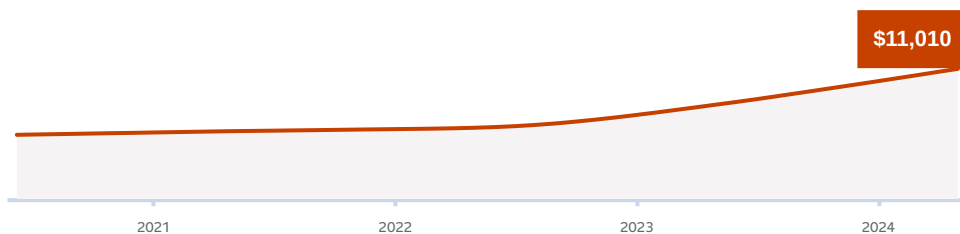


## Sun GIF Solutions Dollar Cost Average Daily Estate Series O
