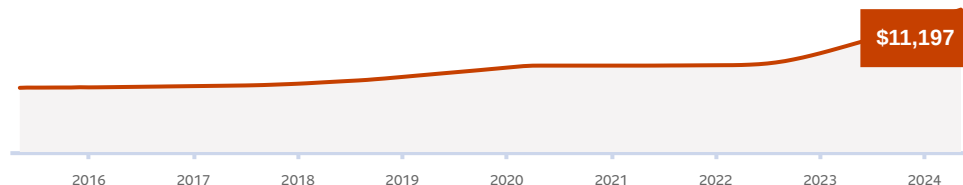


Sun GIF Solutions DCA Daily Interest Investment Series A

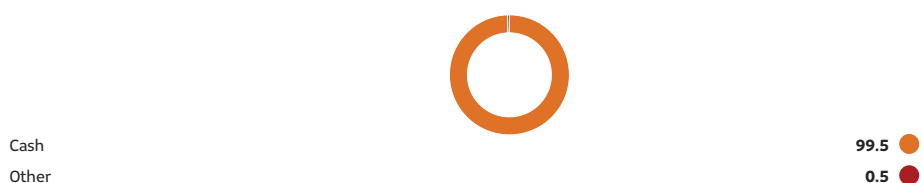
