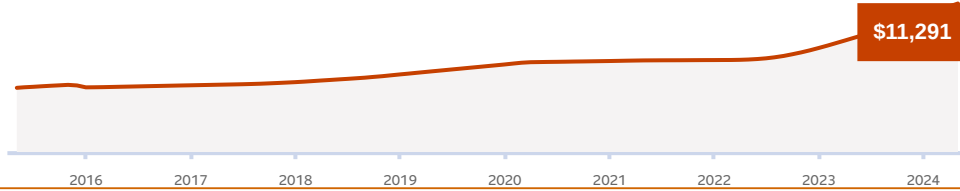


Sun Lifetime Advantage GIF DCA Daily Interest F
