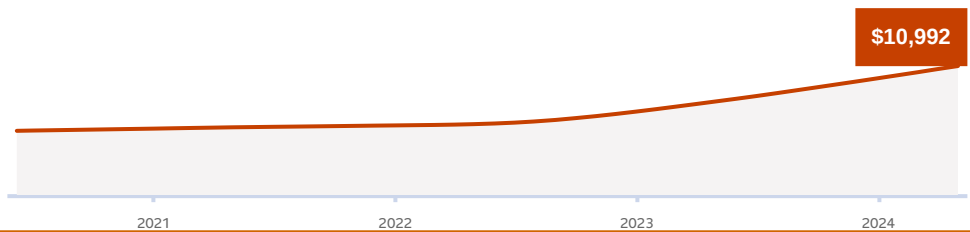


Sun Lifetime Advantage GIF Dollar Cost Average Daily Interest 0
