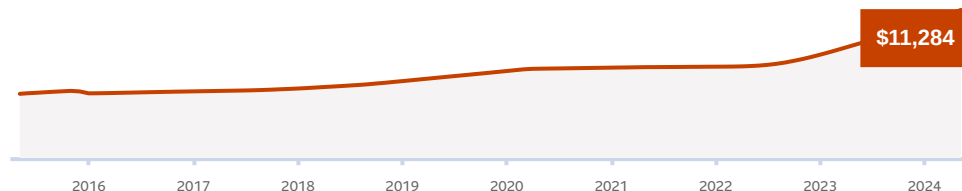


Sun Protect GIF DCA Daily Interest F

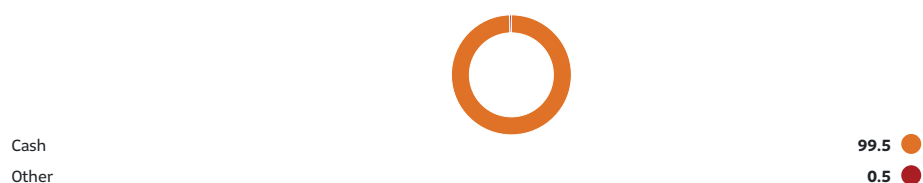
