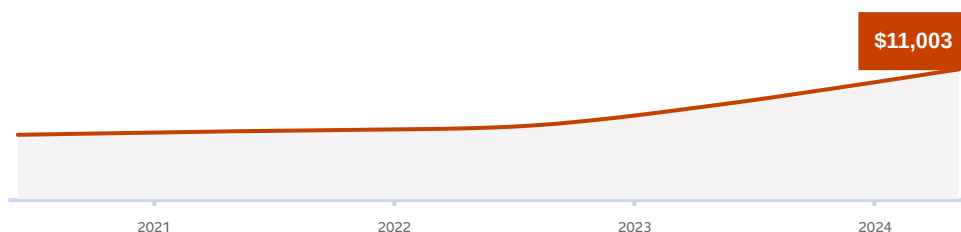


Sun Protect GIF Dollar Cost Average Daily Interest 0

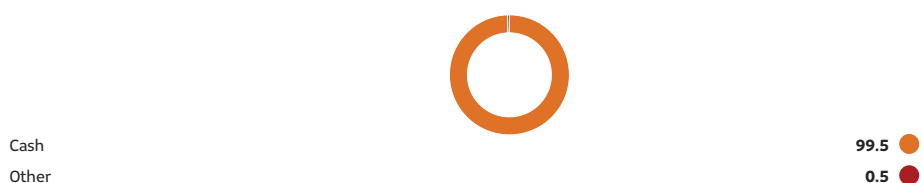
