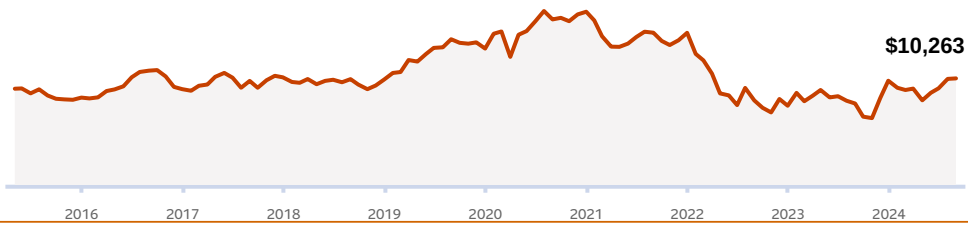


Sun GIF Solutions Strategic Income Income Series F
