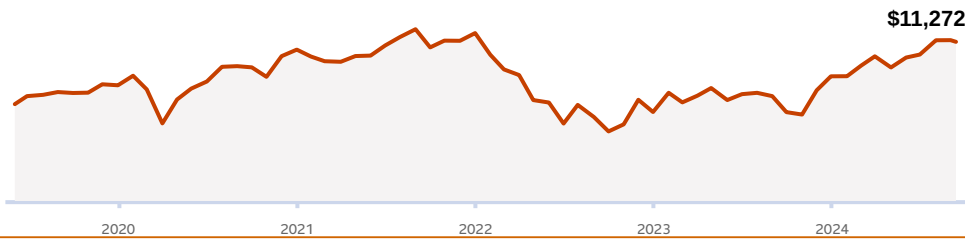


## Sun Lifetime Advantage GIF Enhanced Balanced A
