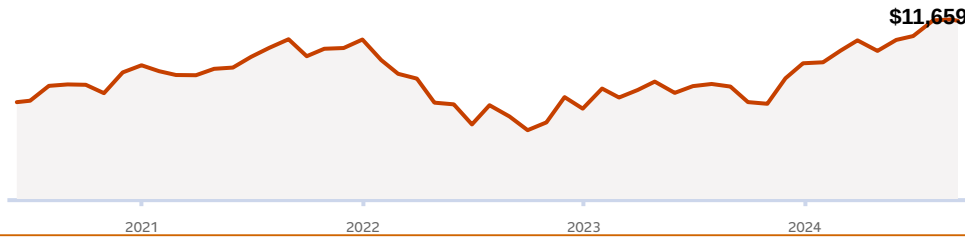


Sun Lifetime Advantage GIF Enhanced Balanced O
