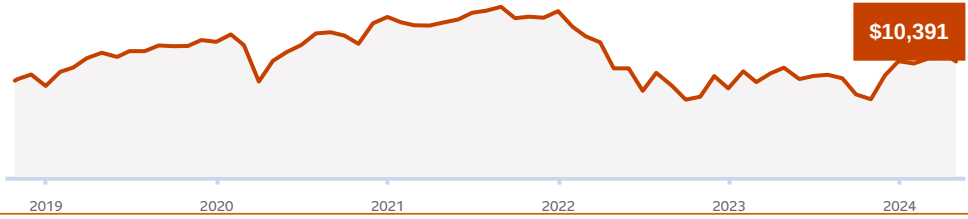


## Sun Lifetime Advantage GIF Sun Life Tactical Conservative ETF Portfolio F
