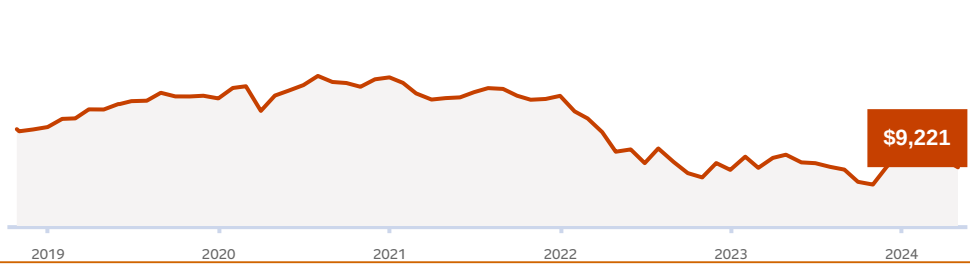


## Sun Protect GIF Sun Life Tactical Fixed Income ETF Portfolio A
