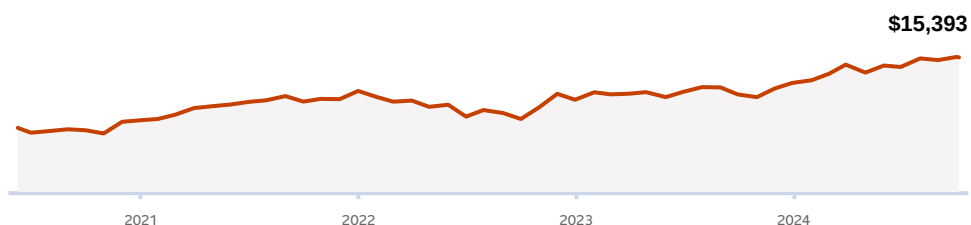


## Sun GIF Solutions Sun Life KBI Global Dividend Private Pool F
