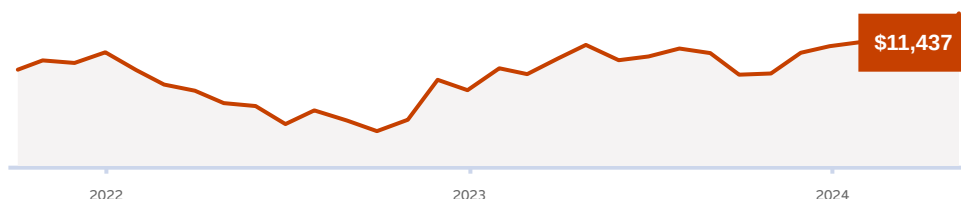


## Sun GIF Solutions MFS Diversified International Equity Investment Series O
